**5** Planning applications for consideration

**5.1** Application: <u>WD/2018/2696/</u>LDE

Location: Broomham Stable, Broomham Lane, Whitesmith, BN8 6JQ

Description: Use of land and existing building as residential in conjunction with equestrian

Response from Chiddingly Parish Council to Wealden District Council: the parish council did not have any knowledge to either support or object to this application.

**5.2** Application: WD/2018/2617/FA

Location: The Old Mill, Chalvington Road, Golden Cross, BN27 3SS

Description: Variation of Condition 5 of planning permission WD/2014/0423/F (change of use from touring static caravans on a 12 month licence, together with alterations to the internal drive, installation of low level lighting and associated landscaping) to allow the permanent residential occupation of static caravans as a main residence.

Response from Chiddingly Parish Council to Wealden District Council: the parish council reached a unanimous decision to **object** to this application. The parish council would rather this site remain as holiday accommodation, as close by there is already a permanent static home residence and the parish council feel that this was be overdevelopment of this type of residence within the area.

Application: WD/2018/2665/F

Location: Coldharbour Meadows, Whitesmith Lane, Chiddingly, BN8 6HB

Description: The provision of an equipped children's play area within the existing tented

campsite.

Response from Chiddingly Parish Council to Wealden District Council: the parish council reached a unanimous decision to recommend approval for this application.

7. Planning application considered via email consultation due to the deadline set by Wealden District Council, and the meeting schedule of Chiddingly Parish Council:

Application: WD/2018/2574/F

Location: Golden Cross Service Station, Golden Cross, Chiddingly, BN27 4AW

Description: Extension, relocation of ATM, new shopfront to the side elevation and new jet

wash.

Chiddingly Parish Council response to Wealden District Council: the parish council reached a majority decision to object to this application, as it includes the closure of the rear entrance to the garage from Burgh Hill Road. Local customers would be forced to exit Burgh Hill Road on to the A22 and then immediately come off the A22 onto the forecourt. With the amount of traffic carried on the A22 this is considered to be a dangerous manoeuvre. The parish council would re consider the application if it didn't include the closure of the Burgh Hill Road access.

Location: Clarklye Barn, Stalkers Lane, Chiddingly, BN8 6HF

Description: Change of use of land and building (380sgm) from agriculture to mixed agriculture and equestrian; provision of 12 stables, feed and tack rooms, solarium and wash down areas within an existing building. Construction of an outdoor riding arena (ménage) and turnout area.
